CHINA AS A LEADER OF THE WORLD ECONOMY

by Gregory C Chow (Princeton University, USA)

After the 1978 Economic Reform, China's economic development has been on a fast track ever since. Later on, the successful accession into the WTO in 2001 accelerated China's economic transformation and made it more integrated with the world. Today, as the second-largest economy in the world, China has earned herself a leading role on the world stage beyond dispute. This book provides readers with answers to why and how China functions as a leader in the world economy.

This book surveys China's economy in four parts economic institutions, economic problems, economic policies and economic analyses. It is based on the author's latest findings from his scholarly research on China's economy, his involvement with China's economic reform and development, and his personal contacts with Chinese academics, entrepreneurs, government officials and ordinary citizens for over thirty years. The book is written in a style accessible to the general readers, since most chapters are based on articles published in three major Chinese newspapers, of which the author is a columnist. It can also serve as a reference book for professionals, an authoritative guide for general readers and a supplementary text for university students. The author uses it as a supplementary text for his course on the Chinese economy at Princeton University.



CHINA INTO ITS SECOND RISE

Myths, Puzzles, Paradoxes, and Challenge to Theory

by James C Hsiung (New York University, USA)

This book seeks to demystify the re-ascendancy of China as a civilization state. China's politics and society are examined in the light of its living civilization, which is the only one of the ancient civilizations that has survived to this day. The book also contrasts China's development with that of the West and Japan. By combining the impact of internal political and socioeconomic developments in China and its external relations (from the silk routes, the tribute system, to the modern day), it unravels the existing myths, puzzles, and paradoxes surrounding China and questions the adequacy of most of the Western political theories (such as realism in international relations) in an attempt to explicate China's re-emergence as a world power. It attempts to tackle squarely the question: Is China a threat to world order?

The book traces the rationale for contemporary developments in China to the roots in the country's tradition as well as foreign influences and seeks to unravel the puzzle about the unique China Model that defies conventional thinking in political economy, with its sustained and incredibly rapid economic growth over the past three decades. This study on China's second rise provides a broad background that includes a meaningful scrutiny of the country's behavior during its first rise (713-1820) and beyond. In comparing China's ongoing second rise with its first ascent, the book not only refocuses on and reinterprets the example set during its first rise, but also takes into account the crucial lessons it learned during its century in eclipse in the interregnum, for the effects they have on the country's current orientation and behavior. The book follows an interdisciplinary approach, combining the cultural, intellectual-historical, normative-ideological, and socialscientific perspectives, to lend a more solid grasp of the present-day China. It ends with an educated speculation, based on the foregoing analyses, on the contours of a Pax Sinica that is likely to result from the impact of China's second rise as a world power.


As China experiences tremendous economic and social transformation in the reform years, language use in China has also undergone remarkable changes in the past couple decades: the national obsession with learning the global English, which becomes both a resource for modernization and a source of contention; the expanding use of local languages and dialects in mass media, where standard Mandarin is promoted and legally prescribed as the principal language; the emergence of the Internet language that has become a creative source for constructing a distinct youth identity: the Cantonese writing movement that challenges the hegemony of the Chinese writing system, which is traditionally based on northern Mandarin, to name a few. The nine papers collected in this volume examine recent trends in language use in mainland China, and the associated social, economic, political, and cultural manifestations. Drawing on their backgrounds and expertise in sociolinguistics, cognitive linguistics, linguistic anthropology, and cultural studies, the authors offer interdisciplinary, insightful, and critical analysis of linguistic struggles and linguistic politics in contemporary China.

As such, the carefully presented details of emerging language use in this book will be of value to scholars interested in language and culture in contemporary China. It may be used as a supplementary text for students in Chinese (socio-)linguistics, Chinese language, Chinese cultural studies, Chinese anthropology, Chinese sociology, and Chinese studies in general.



FOREIGN DIRECT INVESTMENT IN CHINA

Winners and Losers by **Galina Hale** (Federal Reserve Bank of San Francisco, USA) & **Cheryl Long** (Colgate University, USA)

This book provides a comprehensive analysis of the effects that foreign direct investment into China has had on the productivity, exporting activity, and innovation of Chinese domestic firms, as well as on the nation's labor markets. China's Silent Ruler by **Kerry Brown** (Chatham House, UK)

Over the six-month period from late 2012 to early 2013, Hu Jintao, the President of the People's Republic of China, Chair of the Central Military Commission, and Party Secretary of the Chinese Communist Party (CCP), will relinquish at least two of his three positions. According to the constitution of the CCP, his time as Party head will come to an end, given that he has already served for two terms. Well over the supposed retirement age of 68, he will have to hand over the leadership of China to a new generation of leaders at the 18th Party Congress in Beijing. In Chinese politics, the act of retirement is surprisingly difficult, but Hu Jintao is widely known for his reserve and reticence; there is little doubt that he could disappear into a quiet and anonymous retirement if he so desires.

This timely volume thus aims to provide an analytical assessment of Hu's period in charge of the world's most populous country. It concentrates briefly on his early life and entry into politics, then considers and evaluates his stewardship of the economy and of international affairs, as well as his ideological contribution and leadership of the communist party. In the process, the reader will also be afforded a broad overview of China's rapid developments over the last decade, since 2002.



CHEMISTRY IN THEATRE

Insufficiency, Phallacy or Both by Carl Djerassi (Stanford University, USA)

This book examines the questions "What can science do for the theatre?" and "What can the theatre do for science?" which raise challenges for both theatre professionals and scientists. Unusually, this book deals with plays first and foremost as reading material — as texts to be read alone or in dramatic readings — rather than emphasizing performances on the stage. Concrete examples are given to demonstrate the potential pedagogic value of using the dialogic style and plot structure of plays in science, with a special focus on chemistry.

Very few books have dealt with the subject of sciencein-theatre and virtually none with chemistry-in-theatre. Texts of the author's two recent plays, *Insufficiency and Phallacy*, are included in their entirety to offer concrete examples of plays dealing with actual (rather than invented) chemistry. *Insufficiency* represents an example from the field of beer and champagne bubbles, where the topics of academic tenure and fashion in chemistry are analyzed, whereas in Phallacy, a case history of the similarities and differences between science and art is presented for debate.


Concepts, Basic Theories and Applications (2nd Edition)

by **Hiroki Nakamura** (Institute for Molecular Science, National Institutes of Natural Sciences, Okazaki, Japan & National Chiao Tung University, Hsinchu, Taiwan)

Nonadiabatic transition is a highly multidisciplinary concept and phenomenon, constituting a fundamental mechanism of state and phase changes in various dynamical processes of physics, chemistry and biology, such as molecular dynamics, energy relaxation, chemical reaction, and electron and proton transfer. Control of molecular processes by laser fields is also an example of time-dependent nonadiabatic transition.

In this new edition, the original chapters are updated to facilitate enhanced understanding of the concept and applications. Three new chapters — comprehension of nonadiabatic chemical dynamics, control of chemical dynamics, and manifestation of molecular functions — are also added.



QUANTUM CHEMISTRY

A Unified Approach (2nd Edition) by David B Cook (University of Sheffield, UK)

This book is a presentation of a qualitative theory of chemical bonding, stressing the physical processes which occur on bond formation. It differs from most (if not all) other books in that it does not seek to "rationalise" the phenomena of bonding by a series of mnemonic rules. A principal feature is a unified and consistent treatment across all types of bonding in organic, inorganic, and physical chemistry.

Each chapter has an Assignment Section containing "problems" which might be usefully attempted to improve the understanding of the new material in that chapter.

The new edition has had several appendices added which give support to concepts which, if included in the main text, would have hindered the main thrust of the presentation. These new appendices are an attempt to clarify oversights and errors which have been tacitly ignored and which have now become part of the conventional wisdom.

Starting with the basics of set theory, induction and computability, it covers propositional and first-order logic — their syntax, reasoning systems and semantics. Soundness and completeness results for Hilbert's and Gentzen's systems are presented, along with simple decidability arguments. The general applicability of various concepts and techniques is demonstrated by highlighting their consistent reuse in different contexts.


Unlike in most comparable texts, presentation of syntactic reasoning systems precedes the semantic explanations. The simplicity of syntactic constructions and rules — of a high, though often neglected, pedagogical value — aids students in approaching more complex semantic issues. This order of presentation also brings forth the relative independence of syntax from the semantics, helping to appreciate the importance of the purely symbolic systems, like those underlying computers.

An overview of the history of logic precedes the main text, while informal analogies precede introduction of most central concepts. These informal aspects are kept clearly apart from the technical ones. Together, they form a unique text which may be appreciated equally by lecturers and students occupied with mathematical precision, as well as those interested in the relations of logical formalisms to the problems of computability and the philosophy of logic.



ABC OF PHYSICS


Renowned physicist and mathematician Freeman Dyson is famous for his work in quantum mechanics, nuclear weapons policy and bold visions for the future of humanity. In the 1940s, he was responsible for demonstrating the equivalence of the two formulations of quantum electrodynamics — Richard Feynman's diagrammatic path integral formulation and the variational methods developed by Julian Schwinger and Sin-Itiro Tomonoga — showing the mathematical consistency of QED.

This invaluable volume comprises the legendary lectures on quantum electrodynamics first given by Dyson at Cornell University in 1951. The late theorist Edwin Thompson Jaynes once remarked, "For a generation of physicists they were the happy medium: clearer and better motivated than Feynman, and getting to the point faster than Schwinger".

This edition has been printed on the 60th anniversary of the Cornell lectures, and includes a foreword by science historian David Kaiser, as well as notes from Dyson's lectures at the Les Houches Summer School of Theoretical Physics in 1954. The Les Houches lectures, described as a supplement to the original Cornell notes, provide a more detailed look at field theory, a careful and rigorous derivation of Fermi's Golden Rule, and a masterful treatment of renormalization and Ward's Identity.

Future generations of physicists are bound to read these lectures with pleasure, benefiting from the lucid style that is so characteristic of Dyson's exposition.



The revised edition will include a conversation between two fictional characters to elucidate the discussion of the meaning of wave functions.







PHYSICAL BASIS OF PLASTICITY IN SOLIDS

by Jean-Claude Tolédano (Ecole Polytechnique, France)

This book introduces the physical mechanism of the plastic deformation of solids, which relies essentially on the occurrence and motion of dislocations. These are linear defects, specific of crystalline solids whose motion under external stresses explains the relative ease by which solids (metals in particular) can be deformed in order to give them desired shapes. The objective is to introduce the topic to undergraduate students, restricting to the main ideas and showing their relevance in interpreting phenomena well known to everyone (e.g. why are certain metals harder than others?), and finally training the students in the practice of calculating the simplest properties of dislocations.

Contents: Introduction; The Structure of Crystalline Solids; Mechanics of Deformable Solids; Vacancies, an Example of Point Defects in Crystals; The Geometry of Dislocations; Strain Field of Dislocations; Interactions with the Lattice; Microscopic Mechanism of Plasticity.






